

## 2022 FEES AND CHARGES

**Kindergarten Registration Fee:** A non-refundable payment, currently set at \$35.00 per child, contributing to administrative costs associated with the processing of a child’s registration for a place in a program at a BKS kindergarten. This one off fee is paid when the child is first registered with BKS.

**Kindergarten Acceptance Fee:** This fee must be paid by parents/guardians when accepting an offer of a kindergarten place. This payment is retained and deducted from Term fees. Payment will secure the child’s place in the kindergarten program. The Acceptance Fee for 2022 is \$100.00.

**Kindergarten Program Fee:** The Department of Education and Training (DET) provides per capita funding as a contribution toward the costs of providing a three-year-old kindergarten program and a four-year-old kindergarten program. BKS meets the balance of costs through charging fees.

Funding for the 2021 kindergarten year has been increased and as such fees payable have changed.

Kindergarten program fee	Per Term 2022	Full Year Fees for 2022
4 year old program – 15 Hours per week	\$430.00	\$1,720.00 full year
3 year old program – 5 Hours per week	\$144.00	\$576.00 full year

**Are you eligible to be fee exempt? 4 Year Old Program and 3 Year Old Program:** Families who are eligible for the Kindergarten Fee Subsidy (refer to the Kindergarten Registration Handbook for eligibility criteria) will not be required to pay program fees for those terms in which their concession is valid. It is the responsibility of the family to ensure BKS has been provided with current proof of Kindergarten Fee Subsidy eligibility.

**Late Collection Charge:** BKS reserves the right to implement a late collection charge when parents/guardians are frequently late in collecting a child.
